REGISTRATION OF BIRTHS, MARRIAGES AND DEATHS

Births to be registered by the Father or Mother, or in case of inability or death of Parents, then by occupier of the house in which child was born, or by Nurse, within 30 days.

The Occupier of a house in which a death takes place, or some person residing in the house, or any person present, shall record the death before the interment of the body.

Every Clergyman, Minister or other person authorized to celebrate marriages is required to report such marriages within 30 days from the date of marriage.

All returns to be made to the clerk of the local Municipality within which the occurrence to be registered happened.

Refusal or neglect to make these reports, or any of them, within the specified time, will subject the person or persons so neglecting to a **Penalty of Ten Dollars and Costs.**
